**AMENDMENT TO THE REGULATION OF THE MINISTER OF TRADE NUMBER
23/M-DAG/PER/6/2009 CONCERNING PROVISIONS ON TEXTILE IMPORTS AND
PRODUCTS**

**BY THE GRACE OF THE GOD ALMIGHTY
THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,**

Considering : a. whereas in order to defend and increase the competitiveness advantage of national Textile Product Textile Industry (TPT), it is necessary to improve the Regulation of the Minister of Trade Number 23/M-DAG/PER/6/2009 concerning Provisions on Textile Imports and Products;

b. whereas based on the consideration as referred to in item a, it is necessary to stipulate the Regulation of the Minister of Trade;

To stipulate : **HAS DECIDED:**
REGULATION OF THE MINISTER OF TRADE REGARDING AMENDMENT TO THE REGULATION OF THE MINISTER OF TRADE NUMBER 23/M-DAG/PER/6/2009 CONCERNING PROVISIONS ON TEXTILE IMPORTS AND PRODUCTS (TPT).

Article I

Some provisions in the Regulation of the Minister of Trade Number 23/M-DAG/PER/6/2009 concerning Provisions on Textile Imports and Products (TPT) shall be amended bellow:

1. Article 10 shall be amended, so as to henceforth read as follows:

Article 10

- (1) TPT as the process of the Bonded Zone incorporated to other places in the Customs Region shall not apply the obligations of IP-Textile.

- (2) TPT as the process of the Bonded Zone both in part and in whole the standard materials is TPT as the origin of import as provided in Attachment to import as provided in Attachment to the Ministerial Regulation, incorporated into other places in the Customs Area shall apply to the obligation of technical verification or survey.
- (3) TPT as the process of the Bonded Zone, whose the standard materials as a whole come from the domestic productions, incorporated to other places in the Customs Area shall not apply to the provisions on technical verification or survey.
- (4) TPT as the process as referred to in paragraph (2) shall be made the technical verification or survey in the Bonded Zone by Surveyor as already stipulated by virtue of Decree of Minister of Trade Number 948/M-DAG/KEP/7/2009 regarding the Stipulation of Surveyor as the Implementer of Technical Verification or Survey for Textile Imports and Products.

2, Attachment I Regulation of the Minister of Trade Number 23/M-DAG/PER/6/2009 regarding Provisions on Textile Imports and Products shall be amended, so that it has become as provided in the Attachment being an integral part thereof.

Article II

This Regulation of the Minister shall apply as of the stipulation.

For public cognizance, it is ordered to promulgate the Joint Regulation by publish in the State Gazette of the Republic of Indonesia.
